

# **Win your Monsoon spa 2026 with Lumi-O | Innovaplas**

## **1. Description and duration of the contest**

- 1.1.** The “Win Your Monsoon Spa” contest (hereinafter referred to as “the contest”) is organized by Lumi-O | Innovaplas (hereinafter referred to as “the manufacturer”). The contest will be available at Club Piscine retailers (hereinafter “the retailer”).
- 1.2.** Each customer having purchased a Monsoon spa at a Club Piscine retailer has the chance to win the refund of his/her purchase (spa) up to a maximum amount of five thousand nine hundred and ninety-nine (\$5999.00) Canadian dollars plus applicable taxes provided that the terms and conditions of the present rules are respected.
- 1.3.** The amount refunded to the winning customer is the amount paid for their Monsoon spa plus applicable taxes only. Chemicals, delivery, installation or other items on the invoice are not included in the refund. Only the price of the Monsoon spa plus its taxes is applicable. The original invoice is required.
- 1.4.** Only one winner will receive a refund for their Monsoon spa.
- 1.5.** The contest begins on April 15, 2026 and ends on October 1, 2026 at 11:59 pm.
- 1.6.** The contest is organized by the manufacturer, Lumi-O | Innovaplas, whose head office is in Drummondville, Quebec, Canada.

## **2. Eligibility requirements**

- 2.1.** The participant must reside in Canada.
- 2.2.** The participant must be 18 years of age or older.
- 2.3.** The retailers and the manufacturer for whom the contest is held, their employees, representatives, agents or members of their organizations as well as the persons with whom they are domiciled are not eligible to enter the contest.

**2.4.** The purchase of the Lumi-O | Innovaplas Monsoon spa must have been made between April 15, 2026 and October 1, 2026 at a participating Club Piscine retailer offering the contest.

### **3. Conditions of participation**

**3.1.** Upon delivery and installation of the Lumi-O | Innovaplas Monsoon spa, the participant must complete a short online form in its entirety and submit a picture of their spa in their yard. A form and link for submitting the pictures will be available at <https://monsoonspas.com/en-ca/contest>.

**3.2.** The participant must complete the online form outside of Club Piscine retailer's establishment or outside the Lumi-O | Innovaplas offices without the assistance of an employee and/or an officer of the retailer or the manufacturer.

**3.3.** If a participant does not have access to an internet connection, he/she can contact Lumi-O | Innovaplas at 450-565-5544 for immediate assistance during business hours. It will still be possible for the participant to obtain a paper form or to obtain an email link to send their entry and the photo of their spa. However, all information requested on the form must be included in the email.

**3.4.** Winner will be required to correctly answer a mathematical question.

**3.5.** For entry to be valid, the online form must be submitted and received by Lumi-O | Innovaplas no later than 11:59 p.m. on October 1, 2026.

**3.6.** The same person may only enter the contest once per purchase.

**4.4.** The Club Piscine retailer where the winning customer's spa was purchased will be required to provide the winning customer's original purchase agreement and proof that the invoice amount has been paid in full.

**4.5.** The winning customer will be contacted by phone and letter by Lumi-O | Innovaplas within ten (10) business days of the random draw.

**4.6.** The prize will be awarded in the form of a check made out to the winning customer and will be delivered directly to the customer.
